HIGH PROFILE CRIMINAL INVESTIGATIONS

State of Florida v. Charles Martinez (Double 1st Deg. Murder).

Martinez is an admitted serial killer who pled guilty to (2) life sentences for both counts of 1st Deg. Murder in order to avoid the death penalty. This investigation led to the clearance of a previous cold murder. Martinez pled guilty to avoid the death penalty and was sentenced to life.

State of Florida v. Charles Martinez (Cold Case 1st Deg. Murder).

As a result of the double murder investigation against Martinez, probable cause was established to charge Martinez with a cold case murder that he committed approximately four (4) years earlier. Martinez pled guilty to avoid the death penalty and was sentenced to life.

State of Florida v. Washington Beltran (1st Deg. Murder).

Beltran viciously attacked his intended robbery victim at knife point. The victim was stabbed thirty (35) times and his throat was cut. Beltran was identified and later located via forensic investigative techniques. Beltran confessed and DNA tied him to the crime scene. Beltran plead guilty to avoid the death penalty, he was sentenced to life.

State of Florida v. Dade "Ned" Castel (Manslaughter).

Ned Castel was a known drug dealer whose victim died as a result of an overdose via the narcotics sold to him by Castel. The methodology utilized in this investigation was groundbreaking and Castel's subsequent guilty plea was the 1st known conviction of such a case in the Tampa Bay Area. The investigative methodology and strategies utilized during this investigation paved the way for additional such cases to be prosecuted.

State of Florida v. Mannot Lusca (Serial Rapist).

Lusca was a serial rapist who plagued his community via the sexual battery of school age children and home invasions which also resulted in the sexual battery of his victims. These cases remained unsolved for approximately ten (10) years until reopened. The reopening of these cases led to a DNA match, a confession and multiple convictions. Lusca was found guilty via jury trial and was sentenced to life.

State of Florida v. Frankie V. Aguilar (Serial Rapist).

Aguilar was serial rapist who imprisoned and tortured his victims. Aguilar was able to elude prosecution for several years via witness intimidation and the destruction of evidence as such... the investigations into Aguilar's crimes remained unresolved. Aguilar's cases were reopened in 2012 as a result of a victim escaping captivity. This investigation led to multiple convictions and Aguilar was sentenced to life.

State of Florida v. James Larkin (School Principal and Serial Child Molester).

Larkin was a well liked & popular school principal whose (known) victims stemmed from the mid 1970's. Larkin's criminal pattern was typical of a child sexual predator however, through prestige and popularity; his crimes continued for decades despite previous reports of the abuse. In 2014 new allegations into Larkin's criminal conduct led to the launching of a criminal investigation. Investigative methodologies led to the discovery of irrefutable evidence used as the basis to arrest Larkin. His arrest shocked the community which led to victims from decades past to reporting additional crimes. Larkin plead guilty to multiple counts which included a count of Attempted Capital Sexual Battery that had occurred over two (2) decades earlier.

State of Florida v. James Elbert Williams (Serial Rapist).

Williams was fitness trainer who lured his victims via the internet by utilizing false identities. Williams sexually battered dozens of women during the course of his crime spree. In 2011 after becoming aware of his imminent arrest, Williams fled the state of Florida which resulted in a nationwide manhunt. With the assistance of the U.S Marshall's Office, Williams was apprehended in Arkansas. Williams was extradited back to Florida where he pled guilty to his charges.
